MAYOR'S AGENDA

PRESENT: Mayor B. H. "Skip" Henderson, III and Mayor Pro Tem R. Gary Allen and Councilors Charmaine Crabb, Glenn Davis (arrived at 5:34 p.m.), R. Walker Garrett, John M. House, Bruce Huff, Judy W. UPDATES:

 Ft. Benning Update Major General Patrick J. Donahoe, Commanding General

<u>Major General Patrick J. Donahoe</u> approached the rostrum to give an update on Fort Benning and the impact COVID-19 has had on the military installation. He explained the pandemic has caused them to separate the training division from the community, with its 50,000 graduates during the pandemic, and the lack of families visiting Columbus for graduations has impacted the revenue coming into the City. He stated the numbers of positive cases on the installation has been on a steady decline and they are working diligently to administer the vaccination.

REVOCATION HEARING:

1. The Finance Department- Revenue Division's recommendation to revoke the alcoholic beverage license of Mr. Joseph R. Philippe d/b/a Ayden Lounge Bar and Restaurant.

Finance Director Angelica Alexander explained the timeline of events that brought this revocation hearing before the City Council. She explained in January 2020 the Finance Department presented to Council a recommendation of nonrenewal of the 2020 Alcoholic Beverage License for Ayden Lounge Bar and Restaurant based on a criminal history background check conducted on the owner, and Council approved a 90-day extension pending the outcome of a Food and Beverage Audit, which extended the compliance review to April 13, 2020. She stated due to COVID-19, the business closed in March 2020 and reopened July 2020, at which time, the compliance audit resumed. It was determined that the business did not meet the definition of a restaurant as defined in Code Section 3-1(F), where it states at least 50% of the gross food and beverage income should derive from the sale of such meals prepared and served on the premises, which the business failed to meet this requirement.

Revenue Division Manager Yvonne Ivey approached the rostrum to give the percentages of alcohol sales versus food sales for the business in three different timeframes. She stated from September 2019 to August 2020 the alcohol beverage sales were 60.96% and food sales were 39.04%; October 2019 to September 2020 the alcohol beverage sales were 57.41% and food sales 42.59%; and September 2019 to September 2020 the alcohol beverage sales were 58.91% and food sales 41.09%.

Attorney Travis Hargrove (Finley Law Firm, Columbus, Georgia) approached the rostrum to represent the business owner. He requested the Council to take into consideration the current COVID-19 Pandemic and allow a six-month extension to keep the forty-seven employees of Ayden Lounge Bar and Restaurant employed and keeping the doors open to this business. He explained his client has a plan to increase the food sales for the business.

<u>Columbus Police Chief Freddie Blackmon</u> came forward to provide information on calls made to the Columbus Police Department in and around the Ayden Lounge Bar and Restaurant. He explained there have been over twenty-five incident calls between 2018 and December 2020 in and around the business, ranging from assaults, discharge of firearm incidents to reports of theft.

<u>**City Manager Isaiah Hugley**</u> clarified with the Finance Director that there was an application submitted on behalf of a new owner, Latrice Luckerson. It was established there was a bill of sale and cancelled checks provided to the Finance Department, showing the business was legitimately sold.

Joseph R. Philippe came forward to explain he feared losing the liquor license for the business, so he was working to get the ownership transferred to someone else.

James Charles Issac approached the rostrum, stating he is the brother of the business owner. He explained previously they had tried to change the name of the business from Ayden to Tundra and it was explained to him and his brother at that time that they would not be able to be on the liquor license. He explained he has invested \$575,000 in the business and the sale of the business as addressed by the City Manager is not final.

Councilor Woodson made a motion to revoke the alcoholic beverage license of Mr. Joseph R. Phillippe d/b/a Ayden Lounge Bar and Restaurant, seconded by Councilor Tucker and carried unanimously by the nine members present, with Councilor Barnes being absent for the meeting.

<u>City Attorney Clifton Fay</u> explained due to the action taken by Council, it is prohibited that alcoholic beverages be sold at this business.

3. An update on COVID-19

Mayor B. H. "Skip" Henderson gave an update on COVID-19 and the impact on the local community. He explained the 7-day average of citizens being hospitalized due to COVID-19 is thirty-three, and there have been around 20,000 vaccinations administered. He stated originally Columbus was not being given the same number of vaccinations as other cities similar in size, but this issue has been addressed.

CARVER PARK: CHANGE OF HOURS

<u>Councilor Toyia Tucker</u> expressed her concerns regarding the recent violent crimes that have occurred in the community, to include Carver Park. She then made a motion to change the hours of Carver Park to 7:00 a.m. to 7:00 p.m. by oral resolution, seconded by Councilor House and carried unanimously by the seven members present, with Councilors Garrett and Huff absent for the vote, and Councilor Barnes being absent for the meeting.

3. FY2022 Family Connection Grant

4. State Criminal Alien Assistance Program Grant

Resolution (048-21): A resolution authorizing the City Manager, the Mayor, or their designee to submit and accept, if awarded, the Fiscal Year 2022 State Criminal Alien Assistance Program (SCAAP) Funding from the U.S. Department of Justice, in the amount of \$45,690, or as otherwise awarded, with no local match required, and amend the SCAAP Budget by the amount awarded. Mayor Pro Tem Allen made a motion to approve the resolution, seconded by Councilor Woodson and carried unanimously by the eight members present, with Councilor Crabb being absent for the vote, and Councilor Barnes being absent for the meeting.

5. FY2022 FTA 5307 Grant Application for Capital and Planning Assistant

Resolution (049-21): A resolution authorizing the Mayor or City Manager of Columbus, Georgia to submit an application for, and if awarded, accept a grant in the amount of \$2,526,077 or otherwise awarded, from the Federal Transit Administration (FTA) on behalf of the City should the application receive approval. Mayor Pro Tem Allen made a motion to approve the resolution, seconded by Councilor Woodson and carried unanimously by the eight members present, with Councilor Crabb being absent for the vote, and Councilor Barnes being absent for the meeting.

6. Soliciting Interest for Animal Control Services

Resolution (050-21): A resolution authorizing the City Manager to request for qualifications soliciting interest from any Licensed Animal Rescue that has established partnerships with the CCG and has its animal facility/shelter in Muscogee County for the purpose of determining whether the contracting out of Animal Control Services would be feasible to the CCG. Councilor Tucker made a motion to approve the resolution, seconded by Councilor Woodson and carried unanimously by the eight members present, with Councilor Crabb being absent for the vote, and Councilor Barnes being absent for the meeting.

Resolution (051-21): A resolution of the Council of Columbus, Georgia authorizing Columbus Consolidated Government to participate in a memorandum of understanding and intent regarding a Community School Strategy System. The percentage price will be paid by the contractor to the City and will be deposited in the Government Wide Revenue Account.
